

About the Institute



The Institute is a multi-disciplinary research organisation. It takes cognisance of the macro environment, planning processes and strategies including their socio-economic dimensions, and attempts to make interventions through research and dialogues. The Institute is specifically concerned with regional issues related to Rajasthan and western India. In addition to research, the institute undertakes in collaborative work and policy advocacy. As an ICSSR-State Government supported institute since its inception, it aims to promote research, training, consultation, change of scholarship and information dissemination in the state and beyond.

Research Themes:

The research and training in the Institute is focussed around four thematic areas where the faculty with interdisciplinary approach undertake research. These are (i) Economic policies and strategies; (ii) Social policies: Institutions, Governance and Civil Society(iii) Human Development, Urban Poverty and Social Security (iv) Women and Gender Studies. However, with the passage of time and with changing needs, the research interest of the faculty has gone beyond these.

Economic Policies and Strategies

The Institute has been contributing continuously to the domain of economic policies and strategies through its research. The past and present studies include sectoral studies on agriculture, livestock and dairy, non-farm sector, urban informal sector, rural finance, poverty and unemployment.

Social Policies: Institutions, Governance and Civil Society

Under this theme, the focus has been on understanding how State and societies respond to





global challenges of social, demographic and economic change. A number of studies covering different aspects of education, health and sanitation, homeless and empowerment of people, local governance and civil society are conducted by the institute.

Human Development, Urban Poverty and Social Security:

Issues concerning human development, poverty and social security have received attention in IDSJ since inception. Under this theme IDSJ has explored aspects like drafting the Rajasthan Human Development Report, analysing policies of urban poor on sanitation and hygiene, urban homelessness populations and access to social security interventions and urban poverty.

Women and Gender Studies

Gender has been a cross-cutting theme across sectors such as education, violence, sexual and reproductive health, livelihoods and poverty. The faculty has been closely involved in the women's movement both at the state and national level. Mainstreaming gender concerns in policy planning and programmes has been a focus area. The IDSJ faculty continues to research on different aspects of women's subordination and empowerment, gender and education, gender-based violence, reproductive health and rights, adolescent health, gender and sanitation and poverty and livelihood.

Looking Ahead

The IDSJ continues to strive towards achieving academic excellence by producing quality research and publications. We hope to add to our faculty strength in the coming years. This will help further multi disciplinary research, which has been a strength of IDSJ.

Our Partners

During the year 2018-19, the Institute carried out various research projects, seminars and advocacy programmes as per its mandate. Rajasthan Hotspot Baseline Assessment of Child Labour in Jaipur City in collaboration with Development Solutions, New Delhi.

(Supported by Freedom Fund, UK/Development Solutions)

India reportedly has the highest number of child labour in the world. Rajasthan state has the third largest number of child labour in the country and in the capital district of Jaipur, there are an estimated 2,38,000 children (age 14 & under) and adolescents (age 15-17) in some form of work.


The Child Labour Free Jaipur Initiative of Freedom Fund U.K. is focused on eliminating child labour by involving the Government, industry, and local communities. It also seeks to promote cooperation between the Governments of Rajasthan and Bihar to address child trafficking, remove children from exploitative conditions and ensure their reintegration.


The main objective of the baseline evaluation study was to

- Assess Government responsiveness to addressing the issue of child labour both by enforcing the law and enabling the business to become child labour free.
- The shifting of the business norms; reflected in the reduction of the child labour engaged, in sectors such as saree embellishing, embroidery, bangle making and other handicrafts.

The baseline study focused on 3 industries — Bangle making — both natural and chemical lac; Embroidery, embellished sarees and aari-taari, stone sticking and thread work; Fashion/artificial jewellery in Jaipur, Rajasthan. The time period of the project was March, 2018-February, 2019.

The survey of 1,468 work units was carried out in three cluster locations that are known to have high rates of child labour and would be focal points for the Child Labour Free Jaipur Initiative. Three rounds of field data collection were implemented. In addition to the quantitative survey, qualitative modes of enquiry, i.e. Focus group discussions, Key Informant interviews and case study were used to complement the quantitative surveys. The data was collected for the baseline up to November, 2018.





Despite the existence of the 2012 Government order on child labour/trafficking, the coordination between agencies needs to be strengthened. Better coordination could also help in reconciling the administrative data, as information between different agencies does not match.

The focus of government action is more on children who come to Jaipur either from other parts of Rajasthan or other states. This is evident across institutional arrangements, engagement of civil society, the general discourse on the child labour issue and the responses of key officials. There is also a need to focus on children working with families in Jaipur. As the study indicates, they make up the majority of child and adolescent labour in Jaipur.

Understanding Lived Experiences of Teenage Pregnant Girls and Young Mothers in Government Shelter Homes in Rajasthan: A Scoping Study

The period of adolescence has been recognised as a period of rapid psychosocial, cognitive and behavioural maturation. In recent years, challenges facing adolescents have been analysed and documented extensively. Adolescents are a heterogeneous group with diverse needs that vary depending on factors such as age, gender, marital status, place of residence and





educational attainment. Adolescence is also a time when gender roles diverge sharply. Girls and boys experience adolescence in very different ways.

There has been a concerted effort on the part of the governments and development partners to address the needs of young people through policies and programmes directed specifically at them. Despite these efforts, adolescents continue to face several vulnerabilities and challenges. The concerns regarding sexuality, teenage pregnancy and early child bearing in India has been studied in the context of child and early marriage.


Teenage pregnancy outside the framework of marriage is an extremely sensitive issue in the social and cultural contexts where marriage is deemed 'compulsory'. This qualitative study focused on understanding the lived experiences of teenage pregnant girls and young mothers who are residing in the government shelter homes. The effort was to analyse the trends and trajectories of teenage girls who leave home and reach these shelter homes.

The specific objectives of the study were

- To analyse in-depth the circumstances that lead to teenage pregnancy and early motherhood situations.
- To understand how teenage girls cope with child bearing and the responsibilities of child rearing and caring.
- To explore the aspirations and notions of future young mothers under institutional care and challenges therein.
- To map the government support mechanisms in place for girls who find themselves in vulnerable situations, the quality of care provided and the process of reintegration into family and community.

This scoping study used qualitative and partially structured approach. Qualitative methods like Case study, Focus Group Discussion (FGD) and Key Informant Interviews (KII) were used to study the experiences of teenage girls and young mothers under institutional care. The sample for the study was drawn from government shelter homes in Rajasthan.

The shelter homes in the State are primarily located at Divisional headquarters. Three districts were selected for the study. These districts (also the divisional headquarter) are also representative of the different geographical regions of the state i.e. plains, desert and hilly region. Teenage pregnant girls and young mothers who were currently residing in the government shelter homes/Balika Griha were selected for the study.



The study indicates that there is a need to acknowledge that young people have their own needs and aspirations, including sexual desires. It is important to ensure that the transitions of adolescents to sexual life are safe and wanted. Life skills training with special inputs on sexuality education can also help adolescents to be more self-confident, make rational choices protecting their self-esteem and effectively cope with difficult conditions.

Post-Harvest issues in seed spices in India: The case of Coriander and Cumin (Funded by Centre for Development Studies, Thiruvananthapuram, Kerala) Mohanakumar, S.

The research project on Seed Spices in India is based on an extensive field survey of 1000 spices growing farmers in Rajasthan. For cumin cultivators, samples were taken from western part and for coriander, sample farmers were selected from Baran and Kota districts in the south-east part of Rajasthan. In addition to farmers, the study involved detailed market study and the markets APMCs were selected from Gujarat (Unjha Mandi) and Ramganj mandi in Rajasthan. Considering the significant export potential and export-oriented employment generation on the one hand and the imperative of adhering to the quality standards for reaping the export potential on the other, the study explored the post-harvest issues of cumin and coriander. It also explored production conditions, the price realisation as well as quality of the product. The study highlighted several issues in the processing and marketing of cumin and coriander, with implications for policy. To begin with, there are empirical evidences to suggest that the potential for expanding the production is significant. However, there are debilitating production conditions like credit market-product market linkages that needs to be addressed as it leads to lower price realisation. The processing at different levels needs improvement as the existing practices tend to undermine quality. Awareness about the imperative of maintaining quality standards as well as infrastructure for quality testing needs much improvement. A large majority of the growers in both crops are not aware of the Spices Board initiatives to provide polythene sheets at subsidised rates. Though much of the output is sold through auctions, the present method of auction through open outcry system leaves much scope for improvement. Here much could be learned from the e-auction in cardamom





after addressing some of its weakness. It is evident that both production conditions and the post-harvest issues of coriander and cumin in India are more or less the same. On the whole, there is an immense opportunity for improving the farmer-unfriendly conditions that prevails at present. This in turn could attract more farmers to the cultivation of these crops leading not only for enhanced foreign exchange earning but also to improved livelihoods inter alia through export-oriented employment generation.

Endline Survey of Rajasthan Grameen Aajeevika Vikas Parishad (RGAVP), Government of Rajasthan

(Funded by RGAVP, Government of Rajasthan) Mohanakumar, S.


The endline survey involved detailed primary survey of 306 villages and 6000 rural households sampled from 17 districts in Rajasthan. Rajasthan Grameen Aajeevika Vikas Parishad (RGAVP) entrusted the execution of Endline survey with the Institute of Development Studies, Jaipur (IDSJ). Rajasthan Rural Livelihood Project (RRLP) is aimed at promoting self-sustainable livelihood sources to the poor and it is implemented by RGAVP. The project has been implemented in 17 districts in the South East part of Rajasthan since 2011. The RGAVP conducted a Baseline study in 17 districts in 2011. The purpose of the baseline survey was to set benchmark values for outcome and intermediate outcome indicators. The 17 districts covered under the project, there are villages with the intervention or Treatment villages and there exist the other groups without intervention under any of the Rural Livelihood Project Mission or Control Group. The purpose of the Endline study was to understand and report the changes brought about in the intervention households vis-à-vis non-intervention households to study the impact of the RRLP on economic and social empowerment of poor households. Key objectives of the proposed End Line study are: (i) to collect data on the impact of Key Livelihood Indicators of rural households in the project intervention and non-intervention area of RRLP; (ii) Quantify the impact from the project interventions by comparing with those existing at the middle and end of the project; (iii) Understand the changes brought about in the operational landscape of RRLP.

The Primary Survey of Endline study survey was performed by employing Survey CTO software and the data was cleaned and submitted to RGAVP. Important constraint of the study was that the sample population for villages and households in 17 districts were given by the RGAVP and in the field it was found that sample beneficiaries in the base line were not available for the Endline survey primarily on account of the time gap between two surveys.

Human Development Report, Rajasthan, 2018. (Supported by Department of Planning, Government of Rajasthan)

Human Development Report is accepted as an advocacy cum policy document across the Globe. The acceptance of Human Development Report is reflected in the participation of country, states and districts in the preparation of the report in different countries and in India. Human Development Reports, following a standard methodology, measures the level of achievement, Deprivation and inequality across gender in the state. During the last few decades, the state has made substantial progress in increasing the quality of life of the people by introducing policies relating to food security, social security, education and health. The state has made substantial progress in Health, Education, Economic indicators in last decades. It is observed that different sub-castes and tribes with in the broad domain of SCs and STs has made substantial progress in Livelihood, Employment and Education related indicators.

Ongoing Studies

Analyzing Child and Early Marriage in India in collaboration with CWDS, New Delhi.

Early and child marriage has recently come to occupy a prominent place among a range of organizations in India and possibly South Asia. These include women's groups, youth organizations, child rights defenders and groups working in the field of sexuality rights. This study proposes to investigate to what extent the persistence of early and child marriage in India is a by-product of the compulsory nature of marriage in the subcontinent. Using mixed methods both quantitative and qualitative data to be collected from Urban (Jaipur) and rural sites (Sawai Madhopur) for analysis.

Public Expenditure Review of Health in Rajasthan in Collaboration with Centre for Budget and Policy Studies, Bangalore.

This qualitative study forms part of the Public Expenditure Review of Health Status in Rajasthan initiated by CBPS, Bangalore, supported by UNICEF, New Delhi.

The main objectives of the study are:

- To understand the flow of funds within the department of health in the state up to the level of Primary Health Centre (PHC) or Subcentre (SC).
- Review the expenditure of untied funds at each level of health department, i.e. PHC, VHSNC, CHC, DH, RKS etc.
- Understand the role of the VHSNC and GP in development of the GPDP.


The study also seeks to answer the following questions:

- Is the health expenditure in Rajasthan in line with its health priorities?
- How do the changes introduced by the 14th finance commission translate to changes in policy and health expenditures?
- What is the role/share of NHM in health expenditures?
- How participatory is the development of the GPDP at the GP level?

Three districts have been selected for field analysis i.e. Tonk, Dungarpur and Jaisalmer. Key Indepth Interviews (KII) were undertaken with Health department and NHM officials and managers at State, District, Block and GP level (including ASHA). Detailed Tools have been prepared by CBPS Team and shared with state officials and UNICEF team members.

Local Governments and Cronyism in Kerala: A Case Study of Pallichal Gram Panchayat (Funded by Centre for Development Studies, Thiruvananthapuram, Kerala-Consultancy Project)

Uneven Development, Capitalism and Neoliberal Regime in India (Collaborative Research programme with York University, Canada)

The Geography Department of the York University, Canada has undertaken a long-term project titled "Uneven Development, Capitalism and Neoliberal Regime in India". The project is awarded to Professor Raju D. Das of the York University, Canada and coresearchers from India. The part of the project in South India is carried out by Mohanakumar. The collaboration is strictly limited to academic with no financial implications. The objective of the project is to understand how neo-liberal capitalisation credits and aggravates uneven development in India and what are its upshots with respect to different class of people.

Shrinking/degrading Pastoral commons and the livestock economy of Rajasthan, India: Implications for sustainable Development

Supported by Norwegian University of Life Sciences, Ass, Oslo.

Based on primary data from three districts of Rajasthan, present study will examine the challenges faced by households living a livestock base livelihood with the increase in the right wings political move in the country. The contradictory argument of the present political regime at national level on Land and livestock will be examined in detail. This study also tries to understand how the common people's livelihood is being affected by the present policies and narratives created by the right wings political forces. Common land and livestock rearing are complementary to each other. How the new-political regime that came up with two opposite policy agenda, discourage people with livestock-based livelihood. The policy move and narratives created by the right wings political party, forced village livelihood structure to change, made a change in the demographic pattern of the livestock and the common land in the village.

Impunity in Land Rights: A study of the nature, Process and Dynamics of Land Grabbing in Odisha State, India

Supported by Norwegian University of Life Sciences, Ass, Oslo.

Land grabbing is a world-wide phenomenon in present days. Much research has been undertaken to bring out different dimensions of land grabbing. However, the issue of local land grabbing has not yet been adequately addressed. The present study examines the extent and types of land grabbing in Odisha with special reference to the Dalit communities. How the upper class, upper caste and corporate houses grab Land from Dalit households. This

study also examines methods adopted by the perpetrators to grab land from Dalits and what role played by the Civil Society and people movements to address the issue in the state of Odisha.



Mapping and Analysis of Social Protection Schemes for the Girl Child in Rajasthan Sponsored by UNICEF, December, 2018- July, 2019. Kanchan Mathur

This study reviewed both the policy environment and programmatic interventions and recommended a framework and design of an integrated umbrella scheme for empowerment of adolescent girls following a 'cash plus' approach (linking cash transfer with other complementary interventions, set of services and behavior change messaging). It aimed at building on and strengthening the Mukhyamantri Rajshri Yojana, a flagship scheme of the Govt. of Rajasthan launched in June, 2016.

PhD Programme

The Institute of Development Studies has the Ph.D. Programme under the coordinatorship of Dr. S. Mohanakumar. The Ph.D. programme is affiliated to the Central University of Rajasthan. The students for the doctoral programme are selected through the Central University Eligibility Test followed by an interview. On successful completion of the course work, the students join IDSJ and undertake research under the supervision of the faculty members in the Institute. The Indian Council of Social Science Research, New Delhi, awards four fellowships every year to the IDSJ. The first batch of PhD scholars joined IDSJ in March, 2014. The names of PhD Scholars in IDSJ are: Ms. Shaifali Komawath, Ms. Kushboo Sharma, Mr. Ranjeet Kumar, Mr. Rahul Kumar and Mr. Prem Kumar.

Internship

The IDSJ provides internship to graduate students of reputed academic institutions. The programme runs under the coordinator ship of Dr. S. Mohanakumar. The internship is given to those bright candidates, for whom, there is an approval from the head of the Institute. For the last few years, internship is limited to the students from the Central University of Rajasthan (Economics Department). The Internship in the IDSJ is generally given for a period of two months during which the students are expected to undergo rigorous training on research methodology and philosophy. On completion of the course, a research paper on any topic of student's choice is submitted and evaluated.

There were eight students from the Department of Economics, Central University of Rajasthan took internship in IDSJ in August, 2018. The internship was coordinated and successfully completed. The students submitted individual studies of their area of interest in IDSJ as part of the internship programme.

Campus

The Institute's present building was constructed in 1993 with funding from the ICSSR and the Government of Rajasthan. The building comprises a two-storey modest structure, which is now expanded with the construction of a separate training centre-cum-guest house complex.

Library

The institute's library has a rich collection of books, back volumes, research materials, reference data books and other documents relating to various aspects of development and other areas. The library enriched its collection by adding 51 books and other documents during the year, raising the total number to 36,038. The library presently has access to 102 local/national /international journals — among these, there are 30 journals of foreign origin. 54 journals are of the Indian origin. The library also receives 18 journals under certain exchange/complimentary programmes. It also subscribes to 14 daily Newspapers, which helps researchers to keep track of policy and development issues. The IDS library is using CDS/ISIS and WINISIS library software package (developed by UNESCO) for easy and speedy storage, faster processing and retrieval of information system. This also facilitates speedy retrieval of individual volumes /titles based on individual fields such as author, title, subject, keywords and accession number. The system also enables the library users to create print file of the search. The in-house indexing database of published articles of various academic journals touched 44,577 records by the end of March, 2019 in well retrieval/searchable format.

The institute's library is depository library of the World Bank, Asian Development Bank, International Labour Organization, International Monetary Fund, United Nations Research Institute for Social Development (UNRISD) and has so far received 6,224 valuable publications so far under this scheme. In addition, the library houses a rich collection of research and reference material from various international agencies such as FAO (Food and Agriculture Organization), APO (Asian Productivity Organization), IDRC (International Development Research Center, Canada), IFPRI (International Food Policy Research Institute, USA), IWMI (International Water Management Institute, Sri Lanka).

The institute's Library is equipped with 3 PCs for routine library work. The library also has a rich collection of various International Data bases on digital media. World Data (World Bank Indicators of Countries), World Development Sources in 4 CDs by World Bank, World Development Reports CD since 1978. Trade can by UNCTAD, Food & Nutrition Library



by IFPRI and various useful CD databases of the International Labour Organization, Asian Development Bank and the International Monetary Fund make for a compelling collection for scholars and research community.

Finance

The institute was established in 1981, with the support of the Indian Council for Social Scientific Research, New Delhi and the Government of Rajasthan. Since then, the institute has been receiving grant from both the sources.

The institute is trying to raise several project grants for Research, Action Research, Library and Information Services, Seminar, Workshops, including special assignments from the UN agencies, Government of Rajasthan, Ford Foundation, ILO, UNICEF, Oxfam India and others.

During the year 2018-19, the institute incurred core expenditure of Rs. 367.65 lakh and received a sum of Rs. 188.53 lakh from the ICSSR and Rs. 40.00 lakh from the Government of Rajasthan being Maintenance and Development Grant. The institute has also generated income of Rs. 86.78 lakh form own sources during the year 2018-19.


Our Deepest Condolences.
