Conference Overview

Effective financing mechanisms are instrumental in generating livelihoods, stimulating productive employment, and fostering sustainable economic growth. This conference will explore how targeted financial interventions can catalyse development efforts across sectors and regions.

Thus, the conference aspires to bring together leading scholars, researchers, and practitioners from diverse fields such as finance, economics, and development studies, to convene and explore the critical intersection of finance and development and facilitate meaningful dialogue, knowledge exchange, and innovative solutions to pressing challenges in development in India.

Conference Objectives

The primary objective of this conference is to provide a comprehensive platform for scholars to contribute empirical and theoretical research on areas related to banking, finance and development.

Key Themes of the Conference

The conference will feature five thematic sessions, focussing on the following areas:

- **Macroeconomics, Growth, and Financial Stability:** Exploring the interrelationships between macroeconomic policies, growth dynamics, international trade including trade financing, currency risk management, and the impact of global financial systems on trade flows and the stability of financial systems.
- **Climate Finance for Sustainable Growth and Development:** Developing financial markets for innovations to combat effect of climate change risk for building a resilient economy.
- **Finance for Social Sectors Development:** Investigating the role of finance in enhancing social sectors, including health, education, and welfare, to achieve sustainable development goals.
- **Finance for MSMEs and Entrepreneurship Development:** Focusing on financing mechanisms for micro, small, and medium enterprises (MSMEs) and strategies to foster entrepreneurship.
- **Digital Financial Services for Inclusive Development:** Examining the role of digital financial services in promoting financial inclusion, particularly among underserved and marginalized communities.

Submission Guidelines

- ⇒ Papers must be original and previously unpublished, reflecting the conference theme. The word count for the paper should be between 6,000 to 8000 words, including figures, tables, and references. Formatting requirements include A4 size, Times New Roman font size 12, and 1.5 line spacing. References should be cited using APA (7th edition) style.
- ⇒ The authors are requested to submit their full paper electronically in MS Word or PDF format to Email: ids.nibm.ffd2025@gmail.com along with the name, affiliation, mailing address, email address, and contact number of the author. In the case of multiple authors, the paper should indicate the author to whom correspondence should be addressed.
- ⇒ Each submitted paper will go through a blind peer review process, during which it will be evaluated based on the following criteria: originality, depth of technical and/or research knowledge, accuracy, and relevance to the conference's themes and topics.
- ⇒ One of the authors of each accepted paper must register for the conference and agree to present the paper at the conference.
